



SUPPLEMENTARY REGULATIONS FOR THE INDIVIDUAL SPEEDWAY AMZS – MAMS CHAMPIONSHIP 2022

GENERAL RULES

These SR's must be issued by the FMNR responsible for organising the event, and be in accordance with the FIME Sporting Code., with the event being held under the FIM Europe and FIM rules applicable for Track Racing.

Speedway Commission of AMZS-SPORT and Speedway Commission of MAMS inscribe the Individual Speedway AMZS-MAMS- Championship in 2022 in compliance with the FIM and FIME Sporting Code, sporting codes of each nation participating and articles of the REGULATIONS FOR THE INDIVIDUAL SPEEDWAY AMZS – MAMS CHAMPIONSHIP 2022 (hereafter: REG.)

Each organizer of the Championship meeting must prepare the Supplementary Regulations (SR), in compliance with the FIM Sporting Code. The official language of SR is English

NOTES PRACTICE AND RIDERS' BRIEFING MEETINGS

The organizer must provide the practice session open to all riders entered. The practice is not compulsory. Riders will be given one practice session of 3 minutes of free practice. Before the meeting organiser must organise pre-race briefing for all the riders (attendance is obligatory for all the riders).

PAYMENT OF EXPENSES REIMBURSEMENT

All amounts can only be paid to the competitors in € (Euros) according the REG. PAYMENT TO THE RIDERS

PROTESTS AND APPEAL

According the REG. PROTESTS

If the protest relates to an incident during racing, it must be lodged before the riders leave the pits for the next heat. Should the reason for the protest occur in the last heat of the meeting, the protest must be lodged within 10 minutes of the finish of that heat. The protest must be handed to the Clerk of the Course in person, accompanied by a protest fee. The amount of the protest fee is 150 EUR. If the protest is lodged verbally it must be confirmed in writing not more than 15 minutes later In a case that the protest is accepted the accompanying fee will be returned. If protest is rejected the fee will go to the organizer.

LEAVING THE MEETING

No riders may leave the pits, and no machine or engine shall be removed, until after the conclusion of the last race of the event, and then only with the permission of the Clerk of the Course/Race Director.
